## Step two - collect your donations

## Step three - don't forget gift aid!

If you and your fellow fundraisers are UK taxpayers, you can increase your donation at no extra cost to you through Gift Aid. This is a scheme run by the government which allows charities to reclaim the basic rate of tax (20%) on donations made by UK taxpayers. To make your donation worth an extra 25p for every £1 donated, please claim GiftAid Status on JustGiving, or complete this form and return it to us with your cheque.'or complete this form and return it to us with your cheque.

- Don't forget to adhere to the latest social distancing restrictions whilst you are fundraising!
- Please refrain from sending cash in the post for security reasons. Try to use JustGiving or cheques instead.
